

Privacy Policy of GameteExpert website

In our Privacy Policy, you will find information about what personal data we collect when you visit our website, what we do with it, and what rights you have.

Who is responsible for processing your data?

GameteExpert is generally the controller for processing data within the scope of this Privacy Policy, which means that it bears primary responsibility for this data processing under data protection law, unless otherwise specified in individual cases.

What data do we process?

When you visit our website without login we don't collect any personal data.

If you have a login, we save personal data that relates to your identity, such as your name, address, email address, company name. You provide us with this information when you fill in forms on our website or you or a charged institution request a login.

After login we collect certain technical data about your visit, which is recorded in logs, for example the date and time of login, the Internet protocol address (IP address) of the accessing computer, the used browser, and data concerning your interactions with our website.

Why do we process your data?

Data is processed in order to guarantee the functionality, stability and security of our website and technical systems (ensuring security, preventing misuse and illegal activities). We also use it for personal mailings to inform regular participants before, while, and after assessment phase and if we have important information about our service.

Who do we disclose your data to?

Our website is developed, prepared and operated by GameteExpert. To the extent permitted by law, we disclose data to our service provider Hetzner Online GmbH in Germany, working on behalf of GameteExpert to procure IT services in relation to the operation of our website. For how long do we store your data?

We store your data for as long as we are required to do so in accordance with the applicable legal provisions or to fulfil the purpose of its processing. The length of time for which data is stored depends on legal provisions (e.g. supervisory law) and our own internal regulations. If a retention obligation does not (or ceases to) apply, we delete or anonymize your data as part of our normal processes.

How do we protect your data?

GameteExpert has a directive and control system which corresponds to the level of protection customary in the industry. In addition to the general level of protection,

GameteExpert takes further measures (e.g. in the field of cyber risks) to protect personal data.

Which online tracking and analysis techniques do we use for our websites?

We collect and record data about your behavior on our website using cookies and similar technologies. Cookies are codes (e.g. a serial number) which our server sends to your system (browser, mobile) when you connect to our website, and which your system stores until a programmed expiry date is reached. These codes can be read when you access the site in future. This means that you are classed as a unique visitor every time you access a site, and are identified when you log in.

We use session cookies, which store a range of information, including about the origin and storage period of the cookie. These cookies are usually deleted when you close your browser. We also use permanent cookies, which are used to identify an individual visitor when they make a subsequent visit. These cookies are therefore stored for a certain period even after you close your browser. Upon expiry of the programmed duration (which is normally no longer than two years), these cookies are automatically disabled.

We don't use cookies and similar technologies for analytical and marketing purposes.

What are your rights?

You have the right to request information about the processing of your personal data (right of access). You can also request that we rectify incorrect data or supplement incomplete data (rectification). Furthermore, you can also object to us processing your data for specific purposes or revoke any separate consent that you have given. You can also request that we delete certain data.

Please note that the rights mentioned above may be subject to exceptions and restrictions (e.g. to protect overriding interests, the interests of third parties or business secrets).
